INVITATION TO BID

1. Contracting Authority (CA): National Health Insurance Fund (NHIF)
2. CA Address: 2 Jovana Marinovića St., Belgrade

4. Type of CAs: Organization for mandatory social insurance

The National Health Insurance Fund shall on behalf of and for the account of healthcare institutions conduct public procurement procedure and enter into framework agreement based on which the healthcare institutions shall enter into individual public procurement contracts

5. Type of Procedure: open procedure
6. Type of subject: goods
7. Description of scope of procurement, name and designation in Common Procurement Vocabulary (CPV):
 - The scope of public procurement includes medicines for haemophilia treatment; No 404-1-110/17-36
 - Name and Code under CPV:
33600000 – Pharmaceutical Products
8. Number of lots: Public procurement shall be divided in 7(seven) lots
9. Framework Agreement Validity Term: 12 months from signing date
10. Type of Framework Agreement: Framework agreement shall be contracted with single supplier, for all lots he has been allotted
11. Criterion, criterion elements for awarding contract:
 - a) the lowest price for lots 1, 3, 4, 5, 6 and 7
 - b) economically most advantageous bid for lot 2

Criterion		Weighted points
1	Price	60 points
2	Quality	40 points
Total		100 points

I Criterion 1 – Price (maximum 60 points)

Evaluation of Criterion 1 – Price shall be performed upon following formula:

$$\text{Points for Bid X} = \frac{60 * \text{Lowest Price Offered}}{\text{Price Bid X}}$$

II Criterion 2 – Quality (maximum 40 points)

Detailed evaluation of the criterion 2 is given in tender documents.

12. Method of collection of tender documents: tender documents may be downloaded from the Public Procurement Administration Portal and the Client's web address www.javnenabavke.rfzo.rs.

13. Method of bid submission and deadline for bid submission:

- Bidders shall submit their bids to the CA directly or by mail
- Bidders shall file their bids in a closed envelope or a box so as to ensure that during the bid opening procedure it may be verified that an envelope or a box is opened for the first time.
- An envelope or a box containing a bid must be labelled as follows "BID FOR PUBLIC PROCUREMENT OF MEDICINES FOR HAEMOPHILIA TREATMENT - FOR LOT/S _____, Public procurement No. 404-1-110/17-36, - DO NOT OPEN".
- Bidders shall indicate their corporate name, address, phone number, e-mail and responsible persons at the back of an envelope or a box.
- Bids must be submitted directly to the address of the NHFI, 2 Jovana Marinovića St., Belgrade, Registry office, within working hours from 7:30 till 15:30, from Monday till Friday.
- Timely received bids shall be those received by the NHIF by 5th October 2017 by 11:00 am, whatever the method for submission of bids has been used.

14. Place, time and method of bid opening:

- Bids will be opened on 5th October 2017 at 12:00 pm in the premises of the National Health Insurance Fund in Belgrade, 2 Jovana Marinovića St., Auditorium Room No.3.
- Bids shall be opened in the order received/registered by the NHIF.

15. Requirements to be met by bidders' representatives for participation in bid opening procedure:

- Bidders' representatives who chose to attend the session of public bid opening shall present to the NHIF Committee their authorizations for the participation at the session.
- Authorized representatives of bidders participating in bid opening sessions are entitled to make inspection on the data from a bid which will be recorded in the report on bid opening procedure and make remarks on bid opening procedure.

16. Deadline for adoption of the decision: 25 days as of bid opening date, except in especially justified cases, when the deadline for adoption of the decision can be 40 days as of bid opening date.
