INVITATION TO BID in the open public procurement procedure for electricity with balance responsibility for a period of 12 months

1. Contracting Authority (CA): National Health Insurance Fund

2. CA's Address: 2 Jovana Marinovića St., Belgrade

4. Type of CA: Centralized Public Procurement Body

The National Health Insurance Fund, pursuant to Article 17d Item 6 of the Ordinance on Planning and Types of Goods and Services Subject to Centralized Public Procurement ("Official Gazette of the Republic of Serbia", no. 86/13, 119/14, 86/15 and 111/17), as the Centralized Public Procurement Body, is conducting the public procurement procedure for electricity for the year 2018 for the needs of health care institutions with which it has concluded health care provision contracts and for which funds have been allocated for energy sources - electricity within the accounting estimate for 2018, as well as for the needs of its organizational units.

Pursuant to the Decision on Public Procurement by Several Contracting Authorities filed with the National Health Insurance Fund under the reference "08/3 no. 404-540/18" on June 15, 2018, with the Pension and Disability Insurance Fund under the reference "01 no. 404.3-1071/18" on June 15, 2018, with the Institute of Virology, Vaccines and Sera "Torlak" under the reference "2127/1" on June 13, 2018 and with the University of Belgrade - School of Dentistry under the reference "881/3" on June 14, 2018, the National Health Insurance Fund shall conduct public procurement for the needs of the Pension and Disability Insurance Fund, the Institute of Virology, Vaccines and Sera "Torlak" and the University of Belgrade - School of Dentistry.

The National Health Insurance Fund will conduct an open public procurement procedure and enter into a framework agreement, based on which individual public procurement contracts will be signed. Individual contracts will be signed with health care institutions, the National Health Insurance Fund, the Pension and Disability Insurance Fund, the Institute of Virology, Vaccines and Sera "Torlak" and the University of Belgrade - School of Dentistry.

5. Type of Procedure: open procedure

6. Type of goods: goods

- 7. Description of scope of procurement, name and designation in Common Procurement Vocabulary (CPV):
 - The scope of public procurement is electricity with balance responsibility for a period of 12 months;
 - Name and Code under CPV: 09310000-electricity.
- 8. Number of lots: this public procurement is not divided into lots.

- 9. Framework Agreement Validity: one year
 - Number of bidders with which the contracting authority will enter into an agreement with: (1) one
- 10. Criterion, criterion elements for contract award: lowest offered price.
- **11. Method of collection of tender documents:** tender documents may be downloaded from the Public Procurement portal and the CA's web address www.rfzo.rs.

12. Method of bid submission and deadline for bid submission:

- Bidders shall submit their bids to the CA by mail or directly.
- Bidders shall file their bids in a closed envelope or a box so as to ensure that during the bid
 opening procedure it may be verified that an envelope or a box is being opened for the first
 time.
- An envelope or a box containing a bid must be labelled as follows: "BID FOR PUBLIC PROCUREMENT OF ELECTRICITY FOR A PERIOD OF 12 MONTHS, public procurement no. 404-1-112/18-27, - DO NOT OPEN".
- Bidders shall indicate their address, phone number and responsible persons at the back of the envelope or box.
- Bids must be submitted to the address of the National Health Insurance Fund, 2 Jovana Marinovića St., Belgrade to the registry office, on business days from 08:00 until 15:00.
- The timely submission of bids entails their reception by the CA on July 26, 2018 at 11:30 at the latest, whatever the method of submission.

13. Place, time and method of bid opening:

- Bids will be opened on **July 26**, **2018** at **12:00** [noon] in the premises of the National Health Insurance Fund in Belgrade, 2 Jovana Marinovića St., conference room **no. 3**.
- Bids shall be opened in the order received/registered by the CA.

14. Requirements to be met by bidders' representatives for participation in bid opening procedure:

- Bidders' representatives who choose to attend the session of public bid opening shall present to the CA's Committee their authorizations for the participation in the session.
- Authorized representatives of bidders participating in bid opening sessions are entitled to inspect the data from a bid that is recorded in the report on bid opening procedure and make remarks on the bid opening procedure.
- **15. Deadline for adoption of the decision:** 25 days from the bid opening, except for exceptional justified circumstances when the deadline for decision adoption could be extended to 40 days from the day of bid opening.
