## **INVITATION TO BID**

In the open public procurement procedure for fuel for the purposes of healthcare institutions and Serbian Health Insurance Fund for a period of 12 months

- 1. Contracting Authority (CA): Serbian Health Insurance Fund
- 2. CA's Address: 2 Jovana Marinovića St.
- 3. CA's web address: www.rfzo.rs
- 4. Type of CA: Central Public Procurement Body

The Serbian Health Insurance Fund is obliged to conduct the public procurement procedure for fuel pursuant to the Ordinance of the Government of the Republic of Serbia on planning and types of goods and services subject to centralized public procurement ("Official Gazette of the Republic of Serbia", No. 29/13, 49/2013, 51/13-as amended and 86/13), for the purposes of healthcare institutions.

The Serbian Health Insurance Fund shall on behalf of and for the account of healthcare institutions conduct public procurement procedure and enter into framework agreement based on which the healthcare institutions shall enter into individual public procurement contracts,

Apart from conducting the procedure based on healthcare institutions' needs, Serbian Health Insurance Fund shall conduct the procedure for the organizational units' needs.

- 5. Type of Procedure: open procedure
- **6. Type of goods:** goods
- 7. Description of scope of procurement, name and designation in Common Procurement Vocabulary (CPV):
  - The scope of public procurement includes fuel for the purposes of healthcare institutions and Serbian Health Insurance Fund for for a period of 12 months, subject to centralized public procurement conducted by the Serbian Health Insurance Fund pursuant to the Ordinance of the Government of the Republic of Serbia on planning and types of goods and services subject to centralized public procurement ("Official Gazette of the Republic of Serbia", No. 29/13, 49/13, 51/13-as amended and 86/13);
  - Name and Code under CPV: 09100000 fuel.
    - 8. Number of lots: Public procurement shall be divided in 29 lots:
    - 9. Framework Agreement Validity Term: one year
    - 10. Criterion, criterion elements for contract award: economically most favourable bid

## 13. Method of bid submission and deadline for bid submission:

- Bidders shall submit their bids to the CA directly or by mail.
- Bidders shall file their bids in a closed envelope or a box so as to ensure that during the bid opening procedure it may be verified that an envelope or a box is opened for the first time.
- An envelope or a box containing a bid must be labelled as follows "BID FOR PUBLIC PROCUREMENT OF FUEL FOR THE PURPOSES OF HEALTHCARE INSTITUTIONS AND SERBIAN HEALTH INSURANCE FUND FOR A PERIOD OF 12 MONTHS, public procurement No. 404-1-108/14-28, - DO NOT OPEN ".
- Bidders shall indicate their address, phone number and responsible persons at the back of an envelope or a box.
- Bids must be submitted to the address of the Serbian Health Insurance Fund, 2 Jovana Marinovića St., Belgrade– Office No. 13., on working days from 08-15h.
- Timely received bids shall be those received by the Client by 03 March 2014 by 09.30h, whatever the method for submission of bids has been used.

## 14. Place, time and method of bid opening:

- Bids will be opened on 03 March 2014 at 10,00 h in the premises of the Serbian Health Insurance Fund in Belgrade, 2 Jovana Marinovića St., Conference room num 3.
- Bids shall be opened in the order received/registered by the CA.

## 15. Requirements to be met by bidders' representatives for participation in bid opening procedure:

- Bidders' representatives who chose to attend the session of public bid opening shall present to the CA's Committee their authorizations for the participation at the session.
- Authorized representatives of bidders participating in bid opening sessions are entitled to make inspection on the data from a bid which will be recorded in the report on bid opening procedure and make remarks on bid opening procedure.
- 16. Deadline for adoption of the decision: 25 days as of bid opening
