- 1. Contracting Authority (CA): Serbian Health Insurance Fund

The Serbian Health Insurance Fund shall enter into framework agreements and public procurement contracts.

- 5. Type of Procedure: open procedure
- 6. Type of goods: goods
- 7. Description of scope of procurement, name and designation in Common Procurement Vocabulary (CPV):

The subject of public procurement is the material for peritoneal dialysis for home treatments

Name and Code under CPV: 33000000 – Medical Equipment, Pharmaceutical Products and Personal Care Products.

- 8. Number of lots: Public procurement shall be divided in 6 lots
- 9. Framework Agreement Validity Term: 11 months as of the date of signing
- 10. Number of Bidders the CA enters into framework agreement with: framework agreement will be concluded with one bidder
  - 11. Criterion, criterion elements for contract award: the lowest quoted price

## 13. Method of bid submission and deadline for bid submission:

- Bidders shall submit their bids to the CA directly or by mail.
- Bidders shall file their bids in a closed envelope or a box so as to ensure that during the bid opening procedure it may be verified that an envelope or a box is opened for the first time.
- An envelope or a box containing a bid must be labelled as follows "BID FOR PUBLIC PROCUREMENT OF MATERIALS FOR PERITONEAL DIALYSIS FOR HOME TREATMENTS, FOR LOT U/E\_\_\_\_\_\_, public procurement No. 404-1-110/15-64, DO NOT OPEN ".

- Bidders shall indicate their address, phone number and responsible persons at the back of an envelope or a box.
- Bids must be submitted directly to the address of the Serbian Health Insurance Fund, 2 Jovana Marinovića St., Belgrade–Office No. 6, on working days during the working hours of the Serbian Health Insurance Fund
- Timely received bids shall be those received by the CA by 29 Septembre 2015 by 11,30h, whatever the method for submission of bids has been used.
